Request for Proposal conditions 投标邀请书的条件

This Request for Proposal (RFP) is not an offer to contract, but represents a definition of specific requirements and an invitation to qualified companies to submit a response addressing such requirements. 3 Contracting clause 签约条款

Accepting the present Tender Terms is mandatory for participating to the tender. However, accepting the present Tender Terms does not imply automatic acceptance of the General Purchasing Terms and Conditions of Bekaert.

In the absence of making any objection, the General Purchasing Terms and Conditions of Bekaert will also be considered as accepted by participant and shall be applicable to all future deliveries or service performance by participant.
